

Coming Soon: Two New Parks

The City's award-winning parks system is poised for growth following approval in April by the City Commission for the development of two new parks, one in the northwest and one in the southeast areas of the community.

This approval marked a pivotal moment in the community, especially for the development of the northwest park. The 78-acre parcel, which sits near the corner of Mission and Fred George roads, was acquired in 1995. As part of the property acquisition, the prior owner specifically requested that the land be used for a future park, and it has been earmarked for that use ever since.

The City is committed to creating this park in a balanced way that provides the desired active recreational amenities and preserves and enhances passive recreation areas. As such and with funding now available, a natural features inventory and tree survey were conducted this summer on the parcel. To ensure that as much of the natural features are preserved as possible, the tree survey identified trees with diameters of 6 inches or more, which is 6 inches smaller than the industry standard of 12 inches or more. This data is being used to develop the final placement of requested amenities within the site plan, which is currently being designed.

The northwest park is slated to be a comprehensive facility that provides amenities not otherwise available nearby that are enjoyed by residents in other parts of the community. Providing these amenities, which the community has been requesting since property acquisition in 1995, will be balanced with maintaining the beautiful natural areas and trees found on the property. With opportunities for both active and passive recreation, this park will provide greater access to a wider variety of opportunities for thousands of residents.

Once a final site plan is developed, there will be opportunities for the community to provide feedback. Residents who have comments to share now are encouraged to do so using the form available at *Talgov.com/TwoNewParks*. The current timeframe

for the park's development estimates that the final site plan will be ready for community review in late summer, construction could begin later this fall, and a grand opening could occur in late 2019.

Information about the second park, located in the southeast, will be shared as its development process moves forward as well.

In line with the Commission's focus on ensuring a high quality of life for everyone, the City's Parks and Recreation department currently operates and maintains 3,455 acres of well-managed parkland at 88 parks and facilities, ranging from neighborhood playgrounds to nature preserves to regional parks. These two new parks will help meet the growing demand for active recreational facilities and greenspace in the community.

Keys for Keeps

For City employees, building three homes in the Griffin Heights and Frenchtown neighborhoods this spring was a labor of love, made possible by a partnership between the City and Big Bend Habitat for Humanity. Last month, following nearly 2,000 hours of volunteer work, the new homeowners received the keys. These builds were part of the City's efforts to support affordable housing. Earlier this year, the City Commission voted to sponsor this project, in the form of financial support in the amount of \$195,000 and volunteered manpower provided by City employees.

Final Budget Public Hearings

The final budget hearings for Fiscal Year 2019 (FY19) will be held on September 12 and 26 in the City Commission Chambers at City Hall, 300 South Adams Street. Earlier this summer, the Commission voted unanimously to not increase the millage rate, leaving it at its current level of 4.1 mills. The budget planning process for FY19 continues to focus on meeting community needs while improving efficiencies. FY19 begins October 1.
